## TALKING POINTS

#### THE CATALYST

- Rayonier Advanced Materials (RYAM)'s December 2024 site plan application was denied in February 2025 by the City of Fernandina Beach
- The industrial chemical manufacturing is strictly prohibited by the City's Comprehensive Plan and Land Development Code

#### **DANGERS**

- Ethanol is highly flammable the plant would produce 100% pure ethanol
- Ethanol can vaporize into a dangerous gas at any temperature above 57°F
- Flammable ethanol vapors can travel along the ground, be ignited by a spark, and the resulting fire can flash back to the source of the leak
- The potential manufacturing site already processes large quantities of other extremely hazardous and highly reactive chemicals

#### WHY IT IS NOT COMPARABLE TO LOCAL MICROBREWERIES

- Industrial chemical ethanol manufacturing is very different from brewing beer
- Wheat, barley and hops are easily and happily fermented into IPAs, lagers, and porters
- Not so for the process RYAM proposes to employ at the facility, using the spent sulfite liquor RYAM hopes to ferment
  - The raw wood product will have to be pre-treated so that the sugars in it can be fermented
  - Even though this first stage of ethanol production is often called "beer," it is not drinkable
- The next stage, an extensive industrial chemical production processes, produces near 100% pure fuel-grade ethanol
  - o This is a dangerous, highly flammable, and toxic chemical
  - Nothing consumable here
- Beer and spirits are consumable end products with 3%-8% ABV for beers and usually about 40-45% for spirits
- The fuel-grade ethanol RYAM hopes to produce is deadly
- The sheer volume of this manufacturing, 7.5 million gallons annually, is many orders of magnitude greater than any of the local beverage breweries or distilleries

#### **JOBS**

- RYAM has been a long-standing provider of jobs in Fernandina Beach, however bioethanol production is highly mechanized very few new jobs would be created in the facility
- The available plans show only a single control room with three employees for the new facility
- Facility construction would likely provide some jobs, but they would only be temporary

# **TALKING POINTS** (continued)

#### TRAFFIC/TRANSPORTATION

- Before the plant event comes online there would be an immediate uptick in large truck traffic supplying construction materials and prefabricated manufacturing elements in the city
- Once online, three tanker trucks a day (over 1000 a year) will route through our city, across the Shave Bridge, and over the busiest road in Nassau County to I-95
- The US Department of Transportation recommends evacuation zones as wide as a 1/2 mile in all directions from the site of any tanker truck incident involving ethanol

#### **ENVIORNMENTAL CONCERNS**

- In the event of a spill, if ethanol enters water systems it can reduce oxygen levels which harms aguatic life
- Ethanol plants can be linked to air pollution, especially if proper mitigation measures are not in place
- Hazardous air pollutants such as benzene and acetaldehyde could potentially be released into the environment, posing risks to both residents and wildlife
- Facilities such as these play a role in contributing to global greenhouse gas emissions, accelerating the devastating effects of climate change

## ONGOING LEGAL AND LEGISLATIVE ACTIONS

#### The State Suit

- RYAM filed a Building Permit Application which the City denied as prohibited by the City's Comprehensive Plan and Land Development Code
- In February 2025, RYAM filed a lawsuit in State Court alleging Five Counts:
  - o Counts I and III allege that the City Unlawfully denied the Building Permit
  - o Count II alleges the decision is inconsistent with the Comprehensive Plan
  - Count IV alleges the City can't be bound by the Memorandum filed by its attorney Weiss Serota
  - Count V alleges the City's Board of Adjustments is biased and can't decide the issue as per the City Code
- The case has ongoing discovery, gathering testimony and evidence and is moving slowly
- The Court has entered a Pretrial Order setting a Pretrial conference for August 27, 2026 and a trial period beginning August 31, 2026

#### **The Federal Suit**

- In March of 2025, RYAM filed a lawsuit in Federal Court alleging virtually the same allegations as the State court lawsuit with additional constitutional challenges
- The Court denied the City's Motion to Dismiss the Federal lawsuit as the same as the State lawsuit
- In its Order the Court held that under the legal theory of Preclusion, the case will be decided by whichever Court reaches a ruling first
- The case remains pending with a proposed trial date of October 5, 2026

#### **Legislative Action**

- During the 2025 Legislative Session, RYAM supported legislation which was defeated and failed to pass in the Legislature
- It is possible they will bring legislation during the 2026 Legislative Session

#### **The Bert Harris Claim**

- On July 11, 2025, RYAM served the City with a Bert Harris Claim letter alleging the City wrongfully took its property by denying the Building Permit Application and seeks \$6.6 Million Dollars in damages for the loss in the value of the Property
- The City must decide whether to settle this Claim or stand by the Comprehensive Plan and force RYAM to file another lawsuit
